

Ergonomie et psychopathologie du travail

Résumé

A partir des problèmes présentés par la charge de travail et la sûreté des installations sont discutés les apports spécifiques de l'ergonomie d'une part, de la psychopathologie du travail d'autre part. L'analyse ergonomique centrée sur la description du travail réel bénéficie de l'analyse du rapport subjectif au travail et en particulier de la mise en oeuvre de défenses qui ont des incidences sur la maîtrise des risques liées à l'activité. l'auteur insiste ainsi sur la nécessité d'une double approche de l'homme au travail en vue de décrire, mais aussi de transformer les situations de travail.
